## **Parks & Recreation Director's**

Ricky LaPaglia, Parks and Recreation Director reported on the following programs.

Gain Night was held at Kenilworth Sports complex, went well, Recreation handed out info on upcoming programs.

Movie in the Park went very well, with 200 or more attending. There were organizations that sold popcorn, hotdogs, soda, water and more.

Flag Football League just finished there were 100 and some that participated in the league. The peewee football will be going to game in Las Vegas.

C.A.S.P.E.R. at West School is at capacity and there is a waiting list. Heartland School is almost at capacity.

The Youth Soccer league has just started and has about 113 children participating in the league. Toddler

soccer is also going right now. Clinics are held at the Youth Center in the gym, there are 21 children participating.

Men's and Co-Ed Softball tournaments will be held next week. There are eight teams for the Adult Volleyball League.

Upcoming event will be the Christmas Light Parade on December 9.

We are using Bio Feed for the Kenilworth Sports Complex fields. By using Bio Feed the fields should be back to the way they were. Fields have been used a lot.
