

RESOLUTION No. 16-22

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF COOLIDGE, PINAL COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 30, 2016.

WHEREAS, the City of Coolidge, Pinal County, Arizona did hold a primary election on the 30th day of August, 2016, for the nomination/election of a Mayor and Councilmembers; and

WHEREAS, the election returns have been presented to and have been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Coolidge, Pinal County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said primary election, as shown by the poll lists, was 1,439 as follows:





SECTION 5. This resolution shall be in full force and effective immediately upon its adoption.


