

**RESOLUTION No. 20-13**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF COOLIDGE, PINAL COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 4, 2020.**

**WHEREAS**, the City of Coolidge, Pinal County, Arizona did hold a primary election on the 4<sup>th</sup> day of August, 2020, for the nomination/election of a Mayor and (3) Councilmembers; and

**WHEREAS**, the election returns have been presented to and have been canvassed by the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Coolidge, Pinal County, Arizona, as follows:
